Pool Pass Application

Dear Chestnut Grove Resident,

Summer is almost around the corner and that means the pool is about to open! Attached are the Pool Pass Application, CGCA Pool Rules and Regulations, and the 2011 Pool Operating Schedule. You will need to obtain a pool pass if you would like to use the pool. Please note that the CGCA Pool Passes are different than the passes that are issued by Reston Association. RA Pool Passes will not be honored by Chestnut Grove.

Please complete the Pool Pass Application and submit to the onsite office in building 11252 no later than **Saturday, May 22rd** to make sure you receive your pool passes for the opening day. If your application is received after the above due date, your pool passes may not be processed prior to the opening of the pool.

Before pool passes can be issued, the Unit owner's account with Chestnut Grove must be current. We must also have a completed Resident Information Form and any other necessary documents on file at the onsite office. In addition, passes will not be issued to residents not listed on the Resident Information Form.

Guest passes may be requested. The limit is 4 guest passes per unit.

The pool management requires that all children under the age of twelve (12) must be accompanied by an adult (18 years or older) when in the pool area. Children between the ages of twelve (12) and fourteen (14) may be unaccompanied in the pool area upon successful completion of a swimming test.

Keep in mind that this is a community family pool. People wearing inappropriate pool attire may be requested to leave.

All eligible residents will receive their pool passes via hand delivery to their Unit door. Please direct any questions to amenities@chestnutgrovecondo.com.

POOL RULES AND REGULATIONS

The following rules and regulations are for the benefit and protection of residents and their guests to assure the safe and sanitary operation of the pool facilities. Your cooperation and observance will assure pleasant and enjoyable recreation.

1. All persons using the pool or pool area do so at their own risk. The Chestnut Grove Condominium Association (CGCA) assumes no responsibility for any accident or injury in connection with such use, or for any loss or damage to personal property.
2. Persons using the pool area agree not to hold CGCA or pool management liable for any actions of whatever nature occurring within the pool area. Residents will be responsible for the actions of their children, other household members and guests.
3. Persons using the pool area must comply with all rules and regulations promulgated by the City, County and State Health Officers. Admission will be denied to persons with skin abrasions, colds, inflamed eyes or any infection and to any person wearing a bandage.
4. Pool passes are not transferable. They must be deposited with the attendant upon entering the pool and picked up upon departure. The pool passes may be revoked for any reason of misconduct or non-compliance of the rules and regulations as determined by the pool management, community management or the CGCA Board of Directors. If the pool pass is lost, a duplicate may be issued at a charge of \$10.00 upon submission of a written request to the Board of Directors. No one will be admitted to the pool area without a valid pool pass.
5. The pool may be closed at any time, without notice, due to weather, breakdown of equipment or other operational defects.
6. Proper swimming attire must be worn to enter the pool. Infants must have tight fitting rubber pants without diapers.
7. No person with street shoes will be allowed on the pool deck.
8. Clowning or stunt diving is not permitted. Running on the pool deck, unnecessary roughness, horseplay, ball playing and other undue disturbances are strictly prohibited.
9. Tubes, water wings, appropriate pool play equipment, etc. must be cleared by the lifeguard. Play equipment must be removed promptly upon request.
10. Children under twelve (12) years of age must be accompanied by an adult (18 years of age or older) when admitted to the pool area and must remain with that adult during the entire time they are in the pool area. Children between the ages of twelve (12) and fourteen (14) will be required to pass a swimming test in order to attend the pool unaccompanied by an adult.
11. The use of profane language or breaches of the peace will not be tolerated. Pool management, community management or the CGCA Board of Directors reserves the right to refuse entry or deny pool privileges to anyone at their sole discretion.
12. Guests will be limited to four (4) per Unit per day. Adult Unit residents adult (18 years of age or older) must sign in their guests. Guests may be asked to vacate the pool due to over-crowding.
13. Wheeled vehicles or pets of any type are not permitted in the pool area.
14. Glass containers of any type are not permitted in the pool area.
15. Alcoholic beverages may not be brought into the pool area. Food and drink may be consumed in designated areas only.
16. Papers, cigarettes, cigars and refuse must be deposited in the proper receptacles.
